Effect of Penalties on Gender Rotation. The Offended Team Has the Following Three Options (p.9-10):						

1. Decline the penalty, gender advances.

- 2. Accept the penalty, and the yardage, gender advances.
- Accept the penalty, decline the yardage, replay the gender from spot of enforcement.
 If a valid gender play is not run on a closed play, any yardage gained is forfeited, and the ball will be snapped from the previous LOS. Any yardage lost will remain lost.

PENALY ENFORCEMENT (LOS = Line of Scrimmage)

LOOSE BALL ACTION (p.14): Penalty enforced from LOS, except roughing the passer on completed pass (enforced end of run) **RUNNING ACTION** (p.14): Penalty enforced from end of run, unless by offense behind end of run (spot foul)

Dead Ball Fouls: All dead ball fouls are administered separately, and in the order of occurrence. (Fouls do not cancel out) **Multiple Live Ball Fouls** (p.15): Only one live ball foul by the same team may be enforced.

Double Foul (p.15): Accepted live ball penalties by each team. Penalties cancel. Replay the Down AND Gender. (see rules for additional guidance on fouls after change of possession).

Establishing the Zone Line to Gain (p.14): When prior to next ready for play, enforce penalty yardage prior to establishing zone line to gain.

INADVERTANT WHISTLE (p.5): If there's an accepted penalty, administer as usual.

Otherwise, the team in possession may put the ball in play at the dead ball spot, or replay the down.

Exception: When inadvertent whistle during legal forward pass or punt, the down is replayed as if it never happened.
